Two Ohio Valley NARI members win national CotY awards Nears Design & Remodel and Murphy Home Improvement are only winners in region

NARI Region IV would have been shut out of the National Contractor of the Year Awards but for entries from two Ohio Valley NARI Members. Projects by Murphy Home Improvement and Neil's Design & Remodel were the only entries from Ohio, Michigan, Indiana, and Kentucky among the 27 National Coty Award winners announced at the 2008 Evening of Excellence in March.

Neil's national award-winning project was actually an outgrowth of a project that won a local CotY. The home owners engaged Neil's to build a wine closet that won the local CotY award for an interior project. Then they decided they also wanted an attractive outdoor living and entertainment area where they could enjoy their wine.

Again Neal's Design & Remodel came up with a local CotY award winning project, this time in the Residential Specialty (Exterior Addition) category. The project subsequently

won the Region IV award in the Residential Exterior Specialty Category, then was named as the national winner.

Murphy Home Improvement won local and regional Contractor of the Year Awards in the Commercial Exterior category for remodeling the exterior of their own building then went on to win the National CotY for the project.

USEPA announces new lead paint rules for contractors

To further protect children from exposure to lead-based paint, the United States Environmental Protection Agency has issued new rules for contractors who renovate or repair housing, child-care facilities or schools built before 1978.

Lead paint rules have been in place for many years, but they have focused on providing information to home owners. Under the new rules, workers must follow lead-safe work practice standards to reduce potential exposure to dangerous levels of lead during renovation and repair activities.

"While there has been a dramatic decrease over the last two decades in the number of children affected by lead-poisoning, EPA is continuing its efforts to take on this preventable disease," said James Gulliford, EPA's assistant administrator for Prevention, Pesticides and Toxic Substances. "The new rules will require contractors to be trained and to follow simple but effective work practices to protect children from dangerous levels of lead."

The "Lead: Renovation, Repair and Painting Program Rule," which will take effect in April 2010, prohibits work practices that could create lead hazards. Requirements under the rule include specific lead-safe work practices, and certification and training of contractors and maintenance professionals working in pre-1978 housing, child-care facilities and schools. EPA plans to conduct an extensive education and outreach campaign to promote awareness of the new requirements.

The rule covers all rental housing and owner-occupied homes where children under six and pregnant mothers reside. The new requirements apply to renovation, repair or painting activities where more than six square feet of lead-based paint is disturbed in a room or where 20 square feet of lead-based paint is disturbed on the exterior. Affected contractors include remodelers, painters, plumbers and electricians. Trained contractors must post warning signs, restrict occupants from work

NARI adopts major changes to national bylaws in March

At the national board meeting in March NARI adopted some very significant bylaw changes that materially alter the governance of the association.

A major change to the governance structure is establishment of the House of Delegates, consisting of chapter representatives. The NARI Board of Directors will consist of the five elected officers, the chairs of the eight standing committees, the chairs of the Contractor Council, the National Member Council, the Past Presidents Advisory Council, and the Chapter Executives Forum. The executive vice president is a non-voting member of the board. The House of Delegates will elect the officers and appoint the other members of the Board of Directors.

Representation in the House of Delegates is proportional to chapter size and ranges from one delegate for chapters with 15 to 49 members to five delegates for chapters with more than 200 members. Ohio Valley NARI will have two seats in the House of Delegates.

The first meeting of the House of Delegates is set for Thursday, September 11, during the fall NARI National Business Meeting in Baltimore.

The new bylaws eliminate the position of regional vice president.

Ferguson entertains prospective NARI members at casino night event

Lead paint rules (Continued from page 2) areas, contain work areas to prevent dust and debris from spreading, conduct a thorough cleanup, and verify that cleanup was effective.


Lead is a toxic metal that was used for many years in paint. It was banned for residential use in 1978. Exposure to lead can result in health concerns for both children and adults. Children under six years of age are most at risk because their developing nervous systems are especially vulnerable to lead's effects and because they are more likely to ingest lead due to their more frequent hand-to-mouth behavior. Almost 38 million homes in the United States have some lead-based paint.

In September the new EPA lead paint regulations and contractor responsibilities under the regulations will be the focus of presentations at a dinner meeting. Remodeling contractors have been responsible for informing home owners about the potential hazards of lead paint for many years, but the new regulations, which take full effect in 2010, give contractors increased responsibility for remediating lead paint hazards and for minimizing the potential for lead paint exposure during remodeling.

The meeting is set for 6:30 p.m. Thursday, September 11, at the Holiday Inn I-275 North, Hauck Road at I-275 Exit 46.

The November meeting will feature informational round tables on business subjects of vital interest to contractors. Frank Gates is changing its name but not the services and savings for NARI members

In April The Frank Gates Service Company, which has been providing workers' compensation group rating service to Ohio Valley NARI members for many years, began the transition to a new name — Avizent (pronounced ah-VYE-zent).

The ownership and management of Avizent/Frank Gates remain the same. There will be no changes in services or administrative procedures. Al Gardner will continue to be NARI's principal contact at the firm's Columbus office.

Workers' compensation rates are rising and the increases will affect the rates of every employer, including group program participants, but the alternative to being in a group rating program is even worse. During a recent visit to the NARI office AI gave an example of a firm that saw a 100% rate increase to \$1,500 a year. It sounds high, until you consider that outside a group program the same company would pay over \$5,000 a year!

One Ohio Valley NARI member commented that he didn't understand how great the savings can be until he missed the open enrollment period and had to wait a year before joining the program.

If you are not one of the 17 OVNARI mem-

bers currently enrolled in the Avizent/Frank Gates program, or are in another group rating program, you are paying too much for workers comp coverage.
